**No. 9/82/2023-4C2.-** In exercise of the powers conferred under rule-9 of the Haryana Municipal Delimitation of Ward Rules, 1977 and in supersession of all previous orders/notifications issued in this behalf, the Governor of Haryana hereby publishes the following proposal for the delimitation of the wards of **Municipal Committee, Farrukh Nagar, District Gurugram** as specified in the schedule given below for information of the persons likely to be affected thereby.

Notice is hereby given that the draft of notification shall be taken into consideration by the State Government on or after the expiry of period of ten days from the date of publication of this notification in the Official Gazette, together with objections and suggestions, if any, which may be received by the Commissioner and Secretary to Government, Haryana, Urban Local Bodies Department/ Director, Urban Local Bodies Department through **Deputy Commissioner, Gurugram** from any person in respect of the draft notification before the expiry of the period so specified :-

**SCHEDULE OF BOUNDARIES**

**Ward No. 01 :-** Starting point latitude and longitude 28.4746-76.8042 where the north-east boundary of the municipality begins, towards along the boundary in the north direction up to Gaushala Farrukhnagar, then towards the south direction to Sunita's house, then towards in the west direction on the mini-bypass passing along Khem's house to Shell Farm which is the western boundary of the municipality while connecting on the road up to the point no. latitude and longitude. 28.4522-767997, Then along the western and northern boundary of the municipality up to the north-eastern boundary which is the starting point no. latitude and longitude 28.4746-76.8042.

**Ward No. 02 :-** Starting point from Gaushala to the east-south boundary of the municipality and then towards the municipal boundary in the south direction up to Saini School which is on Sultanpur Gurugram Road. After this, along the said road in the west direction on Sultanpur Mode passing in front shop of Harish towards north direction up to Dinesh Yadav's house, then along the west direction up to house of Ratanlal and then towards in the north direction up to the confluence of mini bypass, then on the said road in the west direction up to Vansh Hospital. After that towards Gaushala road in north direction up to Gaushala which is the starting point.

**Ward No. 03 :-** Starting Point from Pradeep's house on Sultanpur-Gurugram Road along the municipal limits in south direction up to the confluence of Wazirpur-Gurugram Road, After this on the above road towards west direction up to Khanna hair dresser shop, then towards in north direction from MR Motors along east direction to Pradeep's house which is the starting point.

**Ward No. 04 :-** Starting point from the office of power house, towards east direction on Wazirpur road up to the municipal boundary point latitude and longitude 28.443-76.8415, then towards the south direction up to municipal boundary point latitude and longitude 28.4136-76.8411, then towards in the west direction up to the point latitude and longitude 28.4153-76.8266, which joints the Fazilpur road. After that along the said road in the north direction up to point latitude and longitude 28.4396-76.8236, then towards East direction via Public Health Office up to Saini Dharamshala, then towards North direction up to office of Power House which is the starting point office of power house.

**Ward No. 05 :-** Starting point Shiv Dayal Saini's shop on bus stand, towards east direction on Wazirpur road up to Sandeep Yadav's plot, then towards south direction up to Ashok's house, then towards west direction up to Sakambhari General Store shop, After this towards North direction on Fazilpur road up to shop of Kirsan Yadav, then in East-North direction towards bus stand up to Shivdayal Saini's shop which is the starting point.

**Ward No. 06 :-** Starting point latitude and longitude 28.4447-76.7969 on Hailymandi Khera-Khurmpur road where the western boundary of the municipality is situated, start towards east direction up to shiv mandir, then towards south direction on Fazilpur road up to khasra no. 189 of kila no. 16 min, After this along the west-northern boundary where the municipal boundary intersects the Pataudi road and the municipal boundary meets the Haily mandi Khera-Khurmpur road which is the starting point latitude and longitude 28.4447-76.7969.

**Ward No. 07 :-** Starting point from the house of Naresh Kumar Dixit towards east direction up to the house of Ramkishan, then towards in south direction up to Jatav Chaupal, then towards west direction on Pataudi road up to the house of Babulal Bawaria, then towards north direction up to the house of Naresh Kumar Dixit which is the starting point.

**Ward No. 08 :-** Starting Point from Gajendra Jain's shop towards east direction up to Sheela Devi's shop, then towards in South-East direction up to Ashok Kumar's house, then towards South direction up to Vijay's shop, then towards west direction passing through Babita Devi's house up to Munshi Ram's house. Then towards north direction up to Gajendra's shop which is the starting point.

**Ward No. 09 :-** Starting point from Chitwan's house towards in east direction up to Rohtas house, then towards in south east direction up to Rekha (Mukesh Fruit) shop, then towards in south direction up to Rajendra's house, then towards in west direction up to Rajendra's house, the towards north direction up to Mola Devi's house, then towards west direction from Rajbala's house up to Girls Senior Secondary School. Then towards in North direction up to Ramotar's house, then towards in West direction up to Sunil Goyal's shop, then towards in North direction up to Chitwan's house which is the starting point.

**Ward No. 10 :-** Starting point from municipal shops, towards east direction (mini bypass) up to Bisan Saini's house, then towards south east direction via Jeevan Jyoti school up to Maman's shop, then towards west direction up to shop of Satbir, then towards west direction up to Saravan shop, then towards north direction Up to Manju's house, then towards west direction up to Nihal Singh's house, then towards south direction up to Indra's house, then towards west up to Bhaneram's house. After this, towards north-west direction up to the house of Vidya Devi, then towards north-east direction up to the municipal shops which is the starting point.

**Ward No. 11 :-** Starting Point from Kamlesh's house towards in East direction up to Madan Saini's house, then towards in North direction up to Netram's house, then towards in East direction up to Gaushala Ground, then towards in South direction via Harchand. Saini's house up to Jain Dental Clinic Hospital, then towards west-north up to Bsanti's house, towards west direction up to Pushpa's house. After that, towards North direction up to Sher Singh's house, then towards west direction up to Motilal Verma's house, then towards North direction up to Kisanchand's shop, then towards East-North direction up to Kamlesh's house which is the starting point.

**Ward No. 12 :-** Starting point from Motilal Verma's house, towards east direction up to Shyam Lal's house, then towards in south direction up to Atar Jain's shop, then towards in west direction up to Digambar Jain's shop, then towards north direction up to Motilal Verma's house which is the starting point.

**Ward No. 13 :-** Starting point from Santosh's house, towards east direction on mini bypass up to Nagar Palika shop, then towards in south-west direction via sadhu's house up to Raghunath's house, then towards west-north direction via Mastram's house up to Laxman's house, then towards in north direction up to Santosh's house which is the starting point.

**Ward No. 14 :-** Starting point from Pushpa's house, towards in east-south direction up to Raghunath's house, then towards in south direction up to Sitaram temple, then towards in west direction up to Saravan's house, then towards in north-west direction up to house of

Om Prakash, then towards in the north-east direction up to the house of Pushpa which is the starting point.

**Ward No. 15 :-** Starting Point From Rajkumar's house, towards in East-South direction up to Veterinary Hospital, then towards in East direction via Arun Jain's shop up to Rajrani's house, then towards in South direction up to Govt. Hospital , then towards in west direction up to Govt. Hospital, then towards in north direction via Municipal office up to Rajkumar's house which is the starting point.

**Ward No. 16 :-** Starting point from Khasra No 65 of Kila no 10, where the west-east boundary of the municipality begins, then towards in the east-north direction up to the house of Balbir, then towards in the south direction up to the house of Pramod, then towards in the west direction up to the house of Mahtab, then towards south direction up to Ramesh's house, then towards West-South direction via Dhankhar School up to Lajij Restaurant, then towards west direction up to the western boundary of municipality which is point Khasra No 69 of Kila no 22, then along western and northern boundary of the municipality up to the north-eastern boundary which is the starting point Khasra No 65 of Kila no 10.
